### What is PL eDelivery?

PL eDelivery is our new inhouse eDelivery platform to deliver policies electronically to our customers.

Customers are able to:

>Review policy package, delivery requirements and payment plan,

- Complete the payment plan for initial premium and recurring,
- ≻eSign all necessary documents,
- Return Delivery Requirements,
- ≻Minimize re-issue delays,
- Request delivery extensions electronically.

By using the inhouse PL eDelivery system, we are able to:

- >Cut cost of mailing a physical policy,
- >Reduce cycle time for delivery of policy and delivery requirements.
- Reduce cycle time in receiving eSigned delivery requirements in house.



Throughout the e-Delivery process, all participants are notified of to-do tasks, status and issues via email.
